Clock is ticking! Count down has started! IRS has announced the start date for E-filing Business returns is January 16th and Individuals January 29th. However, a few forms may be held and not processed until a later date. It generally is the middle of February before all systems are ready and refunds start to process.

Times are changing and we are trying our best to keep up with it! In 2022 we introduced our "TaxDome" program and many of you showed interest and made good use of it. TaxDome allows you to upload personal information and tax documents to your personal portal. We receive a notice you have uploaded and begin the process. Communications through "TaxDome" are personal and discussions of the progress of your return or information needed is the perfect place for keeping a record of conversation for future use. When the return is finished we can upload to your portal for safe keeping. Signing of your tax return after you review or discuss with your advisor can be achieved electronically. If you are not currently using it and want to, call Christy, she will help you get started. A huge thank you to Linda and Christy for implementing this program which was a huge task and still ongoing for perfection and efficient use.

We are here to accommodate you. If you are used to dropping off your information and setting up a time to review and sign you are still welcomed to do so. There isn't a right or wrong way of getting your information to us, it is whichever you prefer.

There is nothing a taxpayer can do that does not affect their taxes. It is often when and how they do what they want to do that determines the best tax outcome. This is why your Tax Preparer has now become your Tax Advisor. The trusted professional to be contacted **before** the action is done, not after and is crucial to the planning process. We appreciate being part of your tax decisions. This allows us to be who we are — individuals critical to the tax well-being of our taxpayers.

We are sure we do not have to tell you the increase in cost that has plagued us all. Preparation of your taxes is based upon our knowledge and expertise, working in your best interest to prepare a return which is both complete and accurate. This requires not only hours of tax education but resources for research to determine the legal nature and best tax positions for

you on your tax return. With the additional requirements of education, security and client confidentiality we will be raising our fees for 2024 tax filing season. For prior clients up to a 20% increase based on the prior year returns will be applied. We value your business and want to be able to continue our partnership of being your trusted professional. Please contact me if you have any questions.

With many professionals choosing to retire or close their practice we have received numerous requests from taxpayers who have been left looking for professional services that we provide. Reluctantly we have limited our engagements of new clients because we want to be available to fulfill our obligations for you.

We receive invites each day to join a "Back Office". This is a company who prepares the returns for us. They are generally located in another country. We have not and will never be part of this activity. We value our personal contact with you and being the only preparer of your return. Although we may not be the fastest, we do try to be thorough and it is always personal with us.

For individuals the Tax Deadline this year is April 15, 2024. Business returns are due March 15, 2024. We encourage you to bring in your information as soon as you have gathered all tax documents. It's not how early you turn in your information, it is how complete the information is. One document we were consistently missing last year was the 1099-SA. This document states how much you spent from your Health Savings Account. Please let us know if you spent it all on Medical. Very important that you used it all for Medical purposes. You may have to access your HSA account on line and look for "tax document".

For Parents who have children in college please print the **1098T** and the summary of charges and payments for the year. For Tuition paid using a **529 plan** please include the form **1099Q**. There are Education credits that may reduce your tax liability. You can get these forms from the online account of your student's college.

We have included a "Checklist" for other documents so you can confirm that you have included all tax documents relative to your tax situation.

Watch for "Tax Documents" to be delivered in the mail during January. Many Investment statements are now online which you will need to print. If you have moved please provide us with your new address! New baby!! Congratulations! Please include the SS card and copy of the birth certificate with your information.

It is our intention to have your return finished by April 15th, however, there are some circumstances when time just doesn't allow for a complete and accurate return to be prepared. Trust me, we more than you, do not like to file an extension. Extensions take as long, if not longer, to prepare due to estimating the amount of tax due to keep our clients from paying penalties. The extension is a request for additional time to file, not to pay. Payment is due with

the extension. We appreciate your cooperation and understanding if we need to file an extension for your return.

FEW NEW THINGS:

The IRS has increased the thresholds for each tax bracket 5.4%. They also lowered the withholding tables and created a new W-4. These are extremely hard to complete, we may be making a suggestion for you to change your W-4 once we get through your tax return for 2023. We can help you with making the changes to get closer to the correct Federal tax withholding for your tax situation.

Many taxpayers use the Standard Deduction instead of itemizing their deductions. The Standard deduction for tax year 2023 – Single \$13,850; Married Filing Joint \$27,700; Head of Household \$20,800. For taxpayers over 65 add \$1,500 to the standard deduction. We always ask that you include your Charitable Contributions and Mortgage Interest and all applicable deductions so we can compare and use the most advantageous for you. In many instances it may not help you on the Federal return but does help you with your State return.

As of the date of writing this newsletter, the Child Tax Credit remains at \$2,000 per child. Refundable is \$1,500. A new proposed tax bill will increase the refundable amount for low to moderate taxpayers. It is proposed to pass for the 2023 filing season. We will definitely keep a close watch on this.

In 2024, the new annual exclusion for gifts is increasing to \$18,000.00, an increase of \$1,000 from 2023. The annual exclusion for gifts refers to the amount of money one person can "gift" another without being subject to a gift tax.

The optional standard mileage rates used to calculate the deductible costs of operating an automobile for business, charitable, medical for 2024 is 67 cents per business mile up from 65.5 for 2023; 21 cents for medical down 1 cent from 2023 and 14 cents for charitable miles unchanged from 2023.

Credits available for 2023 are: up to \$7,500 credit for new, qualified plug-in electric vehicle or fuel cell electric vehicle, many required eligibility requirements apply. Additional eligibility requirement apply for 2024 will need to check the website for updated information. The Retirement Savings Contributions Credit provides a credit of up to \$1,000 for low and moderate income individuals; For 2023, the maximum contribution to an IRA is \$6,500 (\$7,500 for those

age 50 and over). The maximum contribution to a 401(k) is \$22,500 (\$30,000 for those age 50 and over).

Taking RMD (required minimum distributions) for 2023 the age requirement is 73. If you turned 73 in 2023 you are required to take a distribution from your tax deferred retirement account by April 15, 2024. A good deduction for anyone required to take a distribution is to dedicate an amount to a charitable organization before taking the distribution (QCD). The donation goes directly to the organization and you can reduce your taxable distribution by this amount. Your AGI is lower and your tax liability is lower.

CTA

CTA is the Corporate Transparency Act. Under the CTA, entities required to report their beneficial ownership information are identified as Reporting Companies. These encompass any domestic corporation, limited liability company (LLC) and similar entities formed by filing documents with the Secretary of State or a similar office under State or Indian Tribe laws.

Reporting Companies must disclose their beneficial owners' full names, dates of birth, address, unique identifying numbers (e.g. Social Security numbers, driver's license numbers, passport numbers) and a picture of the document containing the unique ID number.

Beneficial Ownership Information (BOI) will be submitted to FinCEN via an online interface and stored through "The Beneficial Ownership Secure System (BOSS). FinCEN will not accept reports until January 1, 2024.

Reporting Companies formed or registered **before January 1, 2024** must submit beneficial ownership information to FinCEN no later than **January 1, 2025**.

Reporting companies formed or registered on or **after January 1, 2024** originally were required to submit Beneficial Ownership (BOI) report to FinCEN within 30 days of formation or registration. **This has now been extended to 90 Days of formation or registration.**

Bezold Tax and Accounting Service is still reviewing all of the requirements and will guide you in the right direction to keep you compliant. CTA is a real thing and to be taken seriously, penalties for non-compliance are \$500 per day up to \$10,000.
